
The tragic pandemic, severe sudden climate events taking place around the world and the strain on global human ecosystems has laid bare the future that we face today, tomorrow and for generations to come.

FOREWORD



We are talking to local communities about their natural heritage, learning how to conserve our natural resources from our ancestors and implementing modern science-based best practices.



We began to update our strategy during the summer of 2020; a period when many parts of the world were under lockdown due to the COVID-19 pandemic. The collective impact of human activity on the environment was top of mind for most people, and we could see the public take a genuine interest in healing our broken relationship with nature. But there was no clear path forward for most people. What actions could they take to prevent further calamities of this ferocity?

We saw this gap as an opportunity to catalyse civil society engagement, mobilise thousands of boots on the ground for environmental conservation and thereby achieve transformative impact for nature and humanity.

CONSERVATION GOALS

WHAT WE INTEND TO ACHIEVE

We are on a mission to ensure that nature thrives and enables the long-term prosperity and resilience of the UAE.

We intend to achieve this by implementing effective, functional long-term solutions that place biodiversity and natural life-supporting systems at the centre of sustainable development in the UAE, in collaboration with government entities, businesses, civil society and future leaders.

This nature-positive approach will help advance technology and innovation, contribute to job creation and create new economic prospects while also delivering benefits to human health, food security and climate resilience.

Our goals are to:

- Conserve & restore natural ecosystems, with UAE's natural ecosystems protected by 2030
- Contribute to a low carbon future,
 with net zero carbon emissions in the UAE by 2050
- Accelerate change towards a sustainable economy by catalysing business decision-making & consumer behaviour by 2030

These efforts support WWF's 2030 global goals to protect and restore nature for the benefit of people and the planet, including a zero loss of natural habitats, zero extinction of species, and halving our footprint (see Figure 1). WWF's three goals are aligned with the UN's Sustainable Development Goals, the UN's Framework Convention on Climate Change, and the Convention on Biological Diversity.



Our new approach complements the ongoing critical conservation projects we implement in partnership with government and corporate partners, by building the capacity to mobilise civil society and achieve scale at a rapid pace. Through the new framework, governments, businesses and civil society can take action for nature together – in collaboration and in cooperation.

The new model's Theory of Change is based on the idea that transformative and lasting conservation impact can only be accomplished through long-term action and behaviour change by all members of society.

All our conservation projects and programmes will be integrated within the Leaders of Change programme, enabling mass-scale action as changemakers to implement conservational impact alongside our team. In turn, all initiatives, events and campaigns designed as part of the programme will be closely integrated with our key conservation pillars and topics of significant relevance to the public and our partners (such as ecotourism, and human health and wellbeing), to ensure that every action contributes to tangible and measurable impact.

We are also sharing this process and insights from our implementation of this new operating model across the WWF network to support transformation at the global scale.

- an engaged community of participants from all facets of society who support our conservation goals by actively participating in our three pillars of engagement - Train, Ideate and Act.




Figure 5. Leaders of Change Programme Overview




Figure 6. Leaders of Change Strategy Overview






LEARN HOW TO MAKE A BIGGER IMPACT

The Train pillar supports the upskilling of our community through science and learning that enables a transition towards a greener nation.

- **Supports green careers** courses and training materials are designed to expand knowledge, build leadership capacity and develop skills that will support individuals in their careers and within the job market.

CHALLENGE THE PAST. CO-CREATE THE FUTURE.


The Ideate pillar is where learning and action meet. Through a range of events, we provide a platform for individuals from the government, private sector, and public to collaborate and create solutions to global environmental, conservation, and sustainability challenges. Bringing civil society together with corporate and government entities via one-on-one and collective discussions helps catalyse ideas, allowing for the creation and implementation of solutions across corporate strategies and government plans.

By promoting dialogue, an exchange of ideas and co-creation of solutions across all sectors of community, we aim to amass change at a large and impactful scale.

FROM IDEATE TO INCUBATE: SOCIAL IMPACT FOR NATURE

Over the next five years, this pillar will evolve from ideating solutions to supporting the incubation of social impact endeavours, building off WWF's Panda Labs model. Volunteers will have the opportunity to be involved at every stage of the ideation process, from inception of the concept to establishment of social enterprises and implementation of solutions to critical conservation challenges (e.g. – eliminating plastic, blockchain for sustainable products, etc).

As the Ideate pillar evolves, the range of co-creation activities will include:





Coalitions, roundtables, majlis discussions which connect audiences across sectors, with the aim that solutions can be implemented collectively across private and public sector for maximum impact

Mentorship and investment opportunities connecting government and corporate entities with youth and social entrepreneurs

The exchange of insights and ideas will be amassed through stringent research and analysis to deliver a blueprint for conservation development which will be shared with stakeholders and key decision makers.

ACT PILLAR

VOLUNTEER FOR NATURE

We anticipate that the Act pillar will become the most exciting part of the Leaders of Change programme as it provides individuals from all sectors of society with access to exclusive conservation opportunities.


Volunteers can assist in scientific field work, support biodiversity mapping efforts, restore natural habitats, build eco-trails, and contribute expertise to internal or coalition projects. The range of activities are broad and will continue to widen as we incorporate volunteering opportunities in upcoming Emirates Nature-WWF partnerships and conservation projects aligned with the organisation's conservation vision and goals.

By mobilising thousands of boots on the ground for self-led and Emirates Nature-WWF-guided volunteering activities, this pillar supports conservation contributions by the public and assures transformative impact at scale.

UAE'S BIGGEST MOVEMENT FOR NATURE

Individual actions taken every day build up over time. By creating a large community of volunteers and empowering them to take frequent actions, we can ensure tangible impact on the ground.

While the initiatives, events and campaigns designed for civil society engagement will evolve over time, they will remain closely integrated to four pathways of conservation that help nature.





Figure 7. Conservation Pathways

CONTEXT OF OUR CONSERVATION WORK

Our three impact areas (Nature & Wildlife Preservation, Accelerate Climate Action, Market Transformation & Green Economic Recovery) prioritise key conservation topics and interventions based on local needs, federal goals, international agreements, and WWF targets and critical contributions. They also take into consideration the most recent opportunities and threats to the environment and human wellbeing. The figure below provides an overview of these opportunities and threats to biodiversity in the UAE that frame the organisation's conservation interventions.




Figure 8. Context of our conservation work

One of the biggest opportunities for our strategy combines action for nature and climate change. The climate-nature nexus will underpin the organisation's efforts to amplify the impact of our work in addressing multiple environmental challenges, while creating links with human wellbeing and economic recovery.

The transition to sustainability requires urgent action across all segments of society. To unlock the exponential power of an active civil society, reduce our collective environmental footprint and boost our economic prospects, we aim to scale up our efforts to involve and create partnerships with government entities, corporates across economic sectors, academia and civil society.

NATURE & WILDLIFE PRESERVATION

GOAL: Enhance and restore natural ecosystems with measurable biodiversity, social and economic benefits for the UAE's green economic recovery.

Emirates Nature-WWF has played a pivotal role in advancing scientific knowledge around endangered species and habitats, as well as supporting the designation and management of key terrestrial and marine areas in the UAE. Over the next five years, we will expand our ongoing partnerships, catalyse civil society action and mobilise resources to increase the protection and effective management of priority areas.

The importance of tackling biodiversity loss is gaining momentum globally and should encourage local and national efforts to safeguard natural ecosystems and the numerous socio-economic benefits they offer. Together with our partners from government and private as well as researchers and communities, we will implement projects that are in line with global post-2020 biodiversity commitments, including the Convention of Biological Diversity and the Ramsar Convention, and deliver science-based management actions to protect and restore critical ecosystems in the UAE.

IMPACT AREA #1

Expand protection and sustainable management of terrestrial, freshwater and coastal ecosystems in the UAE


Based on robust scientific information, our work follows an integrated approach when considering the designation and management of protected areas, which is embedded on broader spatial management measures that aim to enhance ecological connectivity. We also measure and document the socioeconomic benefits of nature and showcase best practices in community engagement and stakeholder participation in ecosystem protection and restoration.

2030 OUTCOME

UAE's natural ecosystems with the richest ecological diversity on land and at sea to be protected and sustainably managed enhancing ecological connectivity and resilience.

2025 TARGETS

- Support expansion of ecosystem protection and effective management of at least
 two priority landscapes in the Hajar Mountains and coastal seascapes of the
 UAE. These areas are home to a rich biodiversity and provide benefits to local
 communities and economies, in the industries of farming, tourism, fishing and
 protection against storms and climate change.
- Restore and sustainably manage at least 20,000 hectares of coastal and 5,000 hectares of terrestrial/freshwater ecosystems to support long-term ecosystem functioning.



ACCELERATE CLIMATE ACTION

GOAL: Support UAE's low carbon transition to achieve net zero carbon emissions and climate resilience

Emirates Nature-WWF has and will continue to support the UAE in the implementation of the National Climate Change Action Plan, National Energy Strategy 2050, and National Determined Contributions to achieve climate resiliency and climate-proof the UAE's economy. The UAE has recently announced ambitions to reach net-zero by 2050, which creates new opportunities for increasing ambition in climate action for both the private and the public sector.

We stand ready to explore opportunities to accelerate the transition towards a low carbon future in line with the UAE's commitment to innovate for 'ideas of the future.' We are also poised to advance dialogue around climate action across sectors and stakeholders, position the UAE's private sector at the forefront of efforts to reduce greenhouse gas emissions and empower civil society to contribute to UAE's low-carbon journey.

A co-benefit of climate action that the UAE's society and economy will realise is a significant improvement in air quality and an overall reduction in air pollution resulting from clean energy sources and sustainable transport and clean transport fuels. Therefore, the potential benefits from all different climate change actions in the UAE can create a major shift in overall health and productivity of the UAE society.



IMPACT AREA #1

Partner with the private sector to climate-proof the UAE economy

Private sector companies will have a key role to play in helping achieve the UAE's emission reduction targets. Emirates Nature-WWF will continue to support businesses in considering their impact on the climate, reducing emissions, and incorporating climate change mitigation and adaptation into their decision-making.

2030 OUTCOME

Mobilise the business community across key economic sectors on GHG emissions Monitoring, Reporting and Verification (MRV) integrating reduction strategies aligned with national and global efforts in climate mitigation and adaptation.

2025 TARGETS

- Ensure that at least 10 companies have set baselines of GHG emissions and actively engage in setting 1.5°C aligned targets.
- Work with new industry segments, such as entertainment, to ensure large scale market transformation and net-zero alignment of at least 2 key players.

IMPACT AREA #2

Enable the implementation of the UAE net-zero commitment and National Energy Strategy

Emirates Nature-WWF will continue to work closely with the government and private sector to enable larger uptake of renewable sources in alignment with the country's National Energy Strategy 2050 and net-zero roadmap. We will also explore the use of policy and best practice to support key sectors towards low carbon future, including the transportation sector.

2030 OUTCOME

UAE is on track to meet the interim targets set for the national net-zero commitment and National Energy Strategy 2050.

2025 TARGETS

- Policy pathways are explored to increase the share of renewable energy in the electricity generation mix considering policy, financial and technology enablers.
- Sustainable transportation options, including Electric Vehicles technology, are integrated into transportation policies and plans with a clear trajectory of infrastructure-ready and policy-ready smart mobility options.

IMPACT AREA #3

Implement Nature-Based Solutions that contribute to climate mitigation and adaptation action

Nature has a key role to play in our efforts to achieve a low-carbon economy.

Nature-based Solutions (NbS) are broadly recognised by international conventions and organizations as critical in delivering biodiversity and broader socio-economic benefits. Studies have demonstrated that NbS can provide approximately one-third of the cost-effective climate mitigation that is required in the next decade to stabilise warming below 1.5°C.

2030 OUTCOME

Nature-Based Solutions in at least one priority area support climate mitigation efforts on the ground by integrating natural carbon sinks into the UAE's National Determined Contributions and GHG Inventories.

2025 TARGET

 At least 20,000 hectares of coastal ecosystems are enhanced and restored in the UAE and function as natural carbon sinks that deliver measurable outcomes on GHG emissions avoidance and reductions while supporting climate adaptation efforts.

IMPACT AREA #4

Promote sustainable lifestyles and wiser consumer choices

Behavioural changes and smart consumer choices can lead to significant emission savings at no cost. Emirates Nature-WWF will identify no-cost/low-cost, high-impact lifestyle and behavioural interventions that can change consumption patterns in the UAE and engage with government stakeholders and civil society to promote wide-scale change.

2030 OUTCOME

An evidence-based governmental and community effort is underway to alter consumption patterns in favour of reduced local and global emissions in line with UAE and global targets.

2025 TARGET

- A large portion of the population in the UAE is aware of the impacts of their consumption patterns on the climate and actively engage in reducing their footprint.
- Synergies between climate change, air quality and human health are identified to inform policy makers, private sector and society.


MARKET TRANSFORMATION & GREEN ECONOMIC RECOVERY


GOAL: Enable a sustainable and circular economic model across key economic sectors in the UAE by catalysing a shift to nature-positive decision making

For over a decade, Emirates Nature-WWF has worked with businesses to drive forth a shift towards sustainable consumption and production patterns. Our goal is to identify innovative solutions and promote market transformation across key economic sectors in the UAE to help accelerate the country's transition towards a sustainable future.

We will continue to examine drivers of environmental degradation and rally stakeholders including corporate leaders, shareholders, consumers and financial institutions to protect the environment in line with government policies.









All events, activities and campaigns developed as part of the Leaders of Change programme will be designed to support the organisation's larger conservation goal and anticipated outcomes. It is therefore critical to measure the impact of this new model to determine the success of the approach and to enhance our programming.

Emirates Nature-WWF's current monitoring & evaluation (M&E) efforts focus on outputs and outcomes of projects, and how these contribute to programme level goals. From 2021 onwards, these plans will include a matrix through which volunteer efforts and conservation work will be assessed against both project goals and wider organisation ambitions, with a focus on the following areas:

- **Conservation outcomes** We have a 20-year track record of focusing on outcomes. We will continue to keep our efforts on track by identifying the progress and wider impact of our conservation projects and initiatives related to our five-year conservation strategy and ten-year impact thesis.
- Leaders of Change contribution to projects Our new Leaders of Change programme hinges on active participation across the train, act, and ideate pillars. Assessment of volunteer contributions will highlight how Leaders of Change are helping nature, strengthening project activities and contributing to our conservation goals.
- Behaviour change Long-term changes in behaviour are crucial for conservation success. We will track how participants evolve their views and behaviours in relation to nature, sustainability, and other relevant topics to ensure the success of the Leaders of Change programme.
- Social impact of government & corporate partners Transformative change requires civil society participation, as well as broad coalitions that include government and private sector partners. Assessment of this impact area will highlight how employees, policies, and initiatives contribute to a nature-positive operating environment in the country.

We will also run volunteer efforts and conservation work through our risks matrix and the Environmental and Social Safeguards Framework (ESSF).

Used by international organisations such as the World Bank and the UN, the ESSF is designed to address a broad range of environmental and social risks. The framework systematises good governance practices to achieve human rights, transparency, non-discrimination, public participation, and accountability, among other goals.



Our work has given us confidence to dream big and embrace an ambitious target – to deliver transformative impact for nature and humanity. We seek to achieve this by supporting civil society and thousands of volunteers to act for nature, by implementing positive change in homes, places of work, universities, schools and beyond.

This is the crux of our five-year strategy for 2021-2025, which is further complemented by internal marketing and engagement, business plans, and financial strategies.

With fine-tuning, innovation and creativity, we aspire to refine our approach and achieve excellence that inspires cities, organisations and communities around the world to foster collective action for people and planet.
